## Chairman’s Welcome

The Annual General Meeting of the Gentlemen of West London Cricket Club (“the Club”) was called to order at 7.25pm on 30 November 2019 at the Bulstrode Bar, Hounslow by the Chairman, who thanked those in attendance.

## Vote of Thanks

Votes of Thanks were passed for S. Bignell who stood as Returning Officer and to the departing Captain and Vice-captain S. Patel and H. Patel.

## Approval of Agenda

The Agenda was unanimously approved as distributed.

## Approval of Minutes

The Minutes of the 2018 AGM were unanimously approved as distributed.

## Treasurer’s Report

- The Club made a profit of **£110.26** over the year. No increase is proposed.
- Income increased by **£675.00** and expenditure by **£1,335.69**.
- The Club will take cleared funds of **£1,361.60** into the 2019/20 financial year.
- Please refer to Appendix I for the Income and Expenditure Account and Appendix II for detailed analysis of pitch costs.

## **Income**

- Sixteen annual subscriptions of **£1,120.00** in total were paid, including one 2019/2020 prepayment. In 2017/8, 18 members paid **£1,260.00** in subscriptions, of whom one prepaid 2018/19.

- Net match fee collections were **£2,487.00**, an increase of **£499.00** over 2017/18. Overpaid match fees of **£160** have been reimbursed.
- There were 256 appearances, so the maximum collectable match fees were **£2,560.00**. Therefore, 97% of match fees were collected.

## Expenditure

- The cancellation by Baker Street Irregulars was catastrophic, the club suffering a wasted pitch @ **£150.00**.
- Pitch costs increased from **£1,436.00** to **£2,006.00** because there were more home games.
- Tea costs increased from **£761.01** to **£894.70** but they were of improved quality.

## Nets

- Nets made a loss of **£66.00**.

## Credits due in 2019

- One game was cancelled by the groundsman and a credit of **£150.00** will be carried forward to 2020.

## Club Secretary's Report

It is good to see a healthy attendance. Ravi Kumar Inkollu is here and will play in 2020. He was the first player from the Telegu-speaking culture of Andhra Pradesh, Telangana and Puducherry to play for us, in 2008. He introduced Murali Kalidindi that year and Patrudu Lalam and Suman Rudru a year later. Ramkrishna Mangineni, Praveen Bocha, Raja Pentakota and Yogenand Kunche followed in 2012 and Vijay Basker in 2013. Ravi therefore planted seeds which grew to the tree whose fruit we enjoy today.

Last season was unusually challenging. Baker Street Irregulars, Gubbays and Wimbledon United cancelled but replacements were found. As a result the Gents met Brentham and for the first time Teddington Town and sublet Wimbledon United's Cottenham RG to accommodate another new opponent, West London. Other new sides played were Byfleet, Plastics and Whalers. Sometimes good things emerge from chaos and we will meet three of these six new opponents again in 2020.

We were delighted to play three games at Wycombe House and I thank their Hon. Cricket Secretary Zahid Ahmed, his brother Aamir and Vasi Shaikh for their help. In an appalling outbreak of bribery and corruption Hemin Patel oiled the wheels with vada pavs and jelaibi.

It is proposed to extend the Committee from five to six by electing a Match Secretary to complement the Fixture Secretary. Therefore we will have a new committee member by the end of tonight.

There was great sadness. We lost Mr Baker, the Old Tenisonians ground manager, Luke Corbett's friend Lizzie Shepherd and our sister Tracey Snelling. We will celebrate Tracey's life in June when we visit Binfield, where the Snellings now play. Thank you Greg Newcombe for your vicious and efficient work as Master of Fines when we raised funds for the Snelling family's chosen charity. Joy came with the birth of Greg's son Albie. Welcome, young sir.

There were a few late changes to teams which was inevitable. We fielded full sides in all but two games when last-minute absences proved impossible to manage.

In the 1990s the season ran from late April to early September, 19 weekends. In 2020 we will play on 24 weekends, with a few Saturday and Sunday double headers before and after the TAL and TAUUK leagues, which run from the second week in May to the second week of August. This will need your usual early declaration of availability.

The loyal support was inspirational. That Aamir Ahmed, Ken Toft and Dino Francis were there so often says a great deal about them.

Thanks to everyone who played, arranged guests or sorted teas and to my fellow Committee members who have bequeathed a financially stable, engaged club.

## The 2020 Season

### **Home ground**

We are in negotiations with Wycombe House CC to increase our allocation in 2020. Old Tenisonians CC will also be used. More information will become available over the winter.

### **Start time**

When the opponents and ground authority agree in advance, we will start home games at 12.30pm in 2020. There is no control over away games. Players should be changed 30 minutes before the game starts to attend to match day tasks (e.g. boundary rope and drinks preparation) and fielding practice.

### **Opposition**

The fixture card is nearly complete. Twenty-five games have been confirmed, including trips to new grounds, Binfield and Kempton. Gubbays have to be slotted in. Rakesh Patel's All Stars will visit in April and Millfields in September. We will not play Baker Street Irregulars, Brentham, Crown Taverners or West London in 2020 but Taverners may return in 2021 if a date can be agreed. A few Saturday and Sunday double headers are planned around the TAL and TAUk leagues, which run from the second week in May to the second week of August

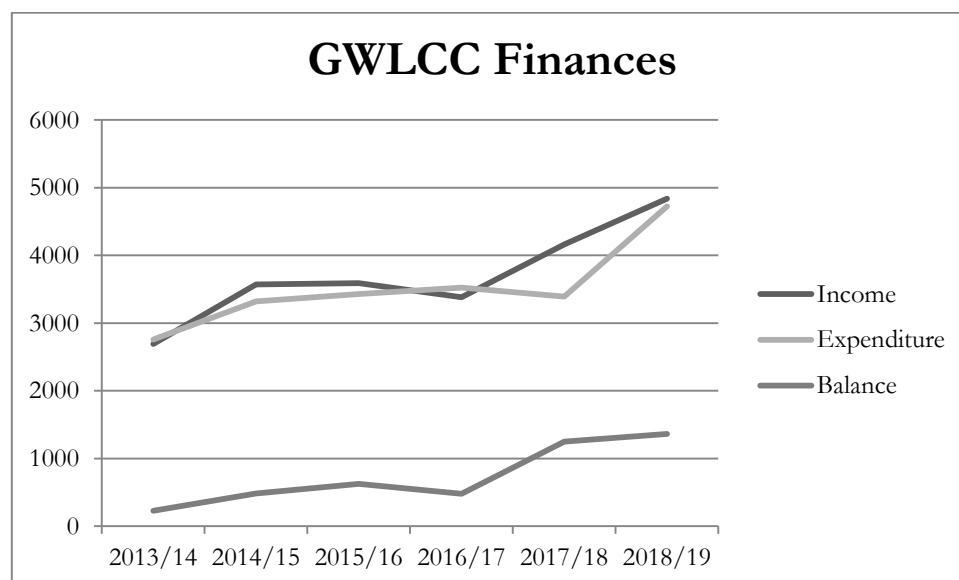

## Appendix III

### **GWLCC Club Constitution**

#### **The Club**

The Club shall be called the Gentlemen of West London Cricket Club (“the Club”).

#### **Committee**

The Club shall be managed by a Committee comprising Chairman, Club and Fixtures Secretary, Match Secretary, Treasurer, Captain and Vice-captain. Each position shall be elected at the Annual General Meeting.

#### **Financial Year**

The Club’s Financial Year shall run from 1 November to 31 October.

#### **Aims and Objectives**

The Aims and Objectives of the Club shall be:

1. To offer competitive cricket to the Club’s Members.
2. To promote the Club within the local community.
3. To ensure a duty of care to all Members of the Club.
4. To ensure that all present and future Members of the Club receive fair and equal treatment.
5. To ensure that all Members abide by the ECB Code of Conduct, which incorporates the Spirit of Cricket, and by the Laws of Cricket.

#### **Annual General Meeting**

1. At least 21 days’ notice of the Annual General Meeting (“AGM”) shall be given by the Club Secretary.
2. The AGM shall receive an audited statement of accounts and reports from the Chairman, Club and Fixtures Secretary, Match Secretary, Treasurer and Captain.
3. Election of the Management Committee shall take place at the AGM.
4. All Members including those elected at the AGM shall have the right to address the AGM and to vote.
5. The quorum for an AGM shall be 10.

#### **Nominations for the Committee**

1. The Club Secretary shall invite nominations at least four weeks before the AGM.
2. The provisional list of nominations shall be issued two weeks before the AGM
3. The final list of nominations shall be issued one week before the AGM. No further nominations shall be permitted.

#### **Voting**

Voting shall be by secret ballot with votes counted by a Returning Officer who shall not be a Member of the Club.

#### **Extraordinary General Meeting**

The Committee has the right to call an Extraordinary General Meeting (“EGM”). The procedure for an EGM shall be the same as for an AGM except that it shall be called at two weeks’ notice. The quorum for an AGM shall be 10.

#### **Membership**

1. Membership of the Club shall be open to anyone interested in cricket on application regardless of sex, age, disability, ethnicity, nationality, sexual orientation, religion or other beliefs. However, limitation of Membership according to the available facilities is allowable on a non-discriminatory basis.
2. The only category of Membership shall be Full Membership, which shall entitle the Member to voting rights, preference over non-Members in regard to team selection, use of the assets of the Club and eligibility for playing awards.
3. The Club is funded by payment of an annual subscription and match fee, the levels of which shall be determined at the AGM. Such charges shall be kept at level that will not pose an obstacle to participation.
4. The Club may introduce different classes of Membership and subscription on a non-discriminatory basis.

5. Application for Membership of the Club shall be by completion of a Membership application form and by payment of the relevant subscription once the applicant has been elected as a Member at the AGM.
6. No person shall be eligible to take part in the business of the Club or eligible for selection for the team unless the appropriate subscription has been paid by the specified date, unless alleviation has been agreed by the Treasurer.
7. The Committee may refuse Membership, or remove it, only for good cause such as conduct or character likely to bring the club or cricket into disrepute. Appeal against refusal or removal may be made to the Committee who shall appoint an Appeals Committee to hear the appeal within 30 days of receipt.
8. All Members shall be subject to the regulations of the Constitution and by joining the Club shall be deemed to have accepted these regulations and any Codes of Conduct that the club has adopted.
9. New Members shall be elected at the AGM.

### **Selection Policy**

1. When a fixture is oversubscribed, the Club shall after discussion between the Match Secretary and the Captain allocate places as fairly as possible.
2. The Club Secretary will ask Members each month to supply their availability. Players must confirm their availability to the Secretary in order to be considered for selection.
3. Members will be selected ahead of guests.
4. Members including those on the Committee can expect to be selected in rotation if matches are oversubscribed.
